Salee Printing Public Company Limited (the "Company") refers to the Board of Directors 's resolutions in the meeting No.3/2020, held on Friday, April 10,2020 to postponement the 2020 Annual General Meeting of Shareholders ("AGM") hold the 2020 AGM on Thursday, April 23, 2020, with undefined date due to the outbreak of the Coronavirus Disease 2019 ("COVID-19"). As a result, the agenda in the AGM regarding the appointment of the auditors and fix the remuneration of the auditors for the year 2020 were postponed.

In this regard, the Board of Directors at the meeting No.2/2020 held on Friday 21, February 2020 with by screening considering and carefully of the Audit Committee, has resolved to propose the appointment of certified public accountants (CPAs) Names of auditors of PricewaterhouseCoopers ABAS Ltd. for 2020, Who is the company's auditor for the first year and CPA to perform duties in place of him or her with the audit fee Baht 1,070,000. - (Including quarterly review). Which the Company will propose for approval by the AGM for the appointment consider approve the 2020 Annual Appointment of Auditors and Determination in the upcoming AGM.

In the absence of the above-named auditors, PricewaterhouseCoopers ABAS Ltd. is authorized to identify one other Certified Public Accountant within PricewaterhouseCoopers ABAS Ltd. to carry out the work.
